SECTION 4 - FIRST AID MEASURES

SECTION 6 - ACCIDENTAL RELEASE and DISPOSAL MEASURES

Spills: Evacuate all non-essential personnel from the spill area. Avoid creating dust. Suitable protective clothing should be worn. Shut off or plug source of spill. Sweep or shovel spilled material into suitable container.
Large Spills: Salvage as much re-useable liquid as possible into a suitable container. Sweep up and shovel without creating dust. Keep in suitable, closed containers for disposal. Avoid contaminating ground and surface water.
