## SECTION 4 · FIRST AID MEASURES

### FIRST AID PROCEDURES:

**Eye Contact:** Flush eyes with plenty of water for at least 15 minutes. Seek medical attention.

**Skin Contact:** Remove contaminated clothing. Wash with soap and water. Seek medical attention if irritation develops.

**Inhalation:** If inhaled, remove to fresh air. If not breathing, give artificial respiration. Seek medical attention if symptoms appear.

**Ingestion:** Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Rinse mouth with water. Seek medical attention/advice.

## SECTION 5 · FIRE FIGHTING MEASURES

**Suitable Extinguishing media:** Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

**Hazardous combustion products:** Oxides of carbon and sodium.

**Fire Fighting Procedures:** As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear.

**Unusual Fire Hazards:** Do not allow water to enter container because of violent reaction. Keep container tightly closed. Powerful oxidizing agent; may ignite oxidizable materials.

**Explosion Hazards:** No published information available.

## SECTION 6 · ACCIDENTAL RELEASE and DISPOSAL MEASURES

**Small Spill:** Use appropriate tools to put the spilled solid in a convenient waste disposal container. If necessary: Neutralize the residue with a dilute solution of acetic acid.

**Large Spill:** Oxidizing material. Stop leak if without risk. Avoid contact with a combustible material (wood, paper, oil, clothing). Keep substance damp using water spray. Do not touch spilled material. Prevent entry into sewers, basements or confined areas; dike if needed. Neutralize the residue with a dilute solution of acetic acid.

## SECTION 7 · STORAGE AND HANDLING

**Handling:** Keep away from heat. Keep away from sources of ignition. Keep away from combustible material. Do not ingest. Do not breathe dust. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes. Keep away from incompatibles such as reducing agents, organic materials, metals, acids, moisture.

**Storage:** Keep container tightly closed. Keep container in a cool, well-ventilated area.

## SECTION 8 · EXPOSURE CONTROLS AND PERSONAL PROTECTION

**Engineering Controls:** Use explosion-proof ventilation equipment. Provide adequate ventilation or other engineering controls to keep the airborne concentrations of vapor or mists below the applicable workplace exposure limits indicated below. The level of protection and types of controls will vary depending upon potential exposure conditions.

**Exposure Limits:** Sodium Percarbonate Contains no substances with occupational exposure limit values.
